

Health System Policy-Coverage

Goal: By 2018, increase DPP reimbursement coverage through at least one Michigan Medicaid plan and one private insurer.

Objective #1: Provide education on reimbursement models, claim codes, overall benefit design, and updates on Medicare DPP coverage as available, to Michigan employers, health plans and MiDPRPs.

Strategy #1: Convene stakeholders and host an educational meeting to share best practices, billing codes, and the DPP return on investment calculator.
